This is an agreement between <u>Elizabeth Country Kennels Pet Resort & Spa</u> and the pet owner whose signature appears below (hereinafter called "Owner").

- 1. Owner agrees to pay the rate for pet care provided in effect on the date pet is checked into Elizabeth Country Kennels Pet Resort & Spa.
- 2. Owner further agrees to pay all costs and charges for special services requested, and all veterinary costs for the pet during the period said pet is in the care of Elizabeth Country Kennels Pet Resort & Spa.
- 3. Owner further agrees that the pet shall not leave the facility until all charges due are paid by Owner or proper payment arrangements are agreed upon by both parties.
- 4. By signing this Agreement and leaving pet with Elizabeth Country Kennels Pet Resort & Spa, Owner certifies to the accuracy of all information given about said pet. Elizabeth Country Kennels Pet Resort & Spa, reserves the right to deny admittance to Owner's pet for any reason at any time.
- 5. Elizabeth Country Kennels Pet Resort & Spa shall exercise reasonable care for the pet delivered by the Owner to the pet care provider. If inter-active playtime is provided, Owner recognizes and accepts potential risks involved in such activity. The Owner further agrees to be solely responsible for any and all acts or behavior of said pet while it is in the care of the pet care provider, to include payment of costs for injury to staff or other animals or damage to facilities caused by the pet. Owner agrees to hold Elizabeth Country Kennels Pet Resort & Spa, its agents, principals and employees, harmless for any and all associated causes related to said injuries and illnesses, including death. Elizabeth Country Kennels Pet Resort & Spa shall not be responsible for loss of any personal articles left with the pet.
- 6. In the rare and unfortunate event that your pet dies in our care, your pet will be taken to your designated veterinarian and maintained for pick up or further instruction.
- 7. Owner specifically represents to Elizabeth Country Kennels Pet Resort & Spa that, to Owner's knowledge, the pet has not been exposed to any contagious diseases within a thirty day period prior to check in. During the period of this Agreement, Owner also agrees to notify Elizabeth Country Kennels Pet Resort & Spa, of any known exposure of pet to a communicable disease and hold pet out of attending Elizabeth Country Kennels Pet Resort & Spa, until pet is symptom free or with written veterinary clearance. Owner further agrees to maintain currency of vaccinations as required by Elizabeth Country Kennels Pet Resort & Spa's policy.
- 8. All charges incurred by Owner shall be payable upon pickup of pet. Owner agrees that if a Third party, previously approved verbally or in writing by Owner and Elizabeth Country Kennels Pet Resort & Spa, picks up pet for Owner, said party will provide payment before pet is released from facility. Elizabeth Country Kennels Pet Resort & Spa shall have the right to hold pet until all charges are paid in full. In the event pet is unclaimed within ten days after the estimated date out, and/or charges are unpaid, Elizabeth Country Kennels Pet Resort & Spa shall dispose of the pet as it deems appropriate.

- 9. If pet becomes ill or injured, or if the state of the animal's health otherwise requires professional attention, Elizabeth Country Kennels Pet Resort & Spa, in its sole discretion, may engage the services of a veterinarian or give other requisite attention to the animal, and the expenses thereof shall be paid by the Owner. The owner further waives any right to dispute whether said expenses were reasonable, necessary and related to the care of the animal in question. Owner agrees to hold Elizabeth Country Kennels Pet Resort & Spa, its agents, principals and employees, harmless for any and all associated causes related to said injuries and illnesses, including death. Owner further understands that Elizabeth Country Kennels Pet Resort & Spa, shall not, at any time, provide veterinary services except for the distribution of pharmacological material(s) as instructed by Owner.
- 10. This Agreement contains the entire agreement between the parties. All terms and conditions of this Agreement shall be binding on the heirs, administrators, personal representatives and assigns of the Owner and Elizabeth Country Kennels Pet Resort & Spa.
