This is an agreement between Top Dog Kennel Club DBA Elizabeth Country Kennels and the pet owner whose signature appears below (hereinafter called “Owner”).

1. Owner agrees to pay the rate for pet care provided in effect on the date pet is checked into Top Dog Kennel Club DBA Elizabeth Country Kennels.
2. Owner further agrees to pay all costs and charges for special services requested, and all veterinary costs for the pet during the period said pet is in the care of Top Dog Kennel Club DBA Elizabeth Country Kennels
3. Owner further agrees that the pet shall not leave the facility until all charges due are paid by Owner or proper payment arrangements are agreed upon by both parties.
4. By signing this Agreement and leaving pet with Top Dog Kennel Club DBA Elizabeth Country Kennels, Owner certifies to the accuracy of all information given about said pet. Top Dog Kennel Club DBA Elizabeth Country Kennels, reserves the right to deny admittance to Owner’s pet for any reason at any time.
5. Top Dog Kennel Club DBA Elizabeth Country Kennels shall exercise reasonable care for the pet delivered by the Owner to the pet care provider. If inter-active playtime is provided, Owner recognizes and accepts potential risks involved in such activity. The Owner further agrees to be solely responsible for any and all acts or behavior of said pet while it is in the care of the pet care provider, to include payment of costs for injury to staff or other animals or damage to facilities caused by the pet. Owner agrees to hold Top Dog Kennel Club DBA Elizabeth Country Kennels, its agents, principals and employees, harmless for any and all associated causes related to said injuries and illnesses, including death. Top Dog Kennel Club DBA Elizabeth Country Kennels shall not be responsible for loss of any personal articles left with the pet.
6. In the rare and unfortunate event that your pet dies in our care, your pet will be taken to your designated veterinarian and maintained for pick up or further instruction.

7. Owner specifically represents to Top Dog Kennel Club DBA Elizabeth Country Kennels that, to Owner's knowledge, the pet has not been exposed to any contagious diseases within a thirty day period prior to check in. During the period of this Agreement, Owner also agrees to notify Top Dog Kennel Club DBA Elizabeth Country Kennels, of any known exposure of pet to a communicable disease and hold pet out of attending Top Dog Kennel Club DBA Elizabeth Country Kennels, until pet is symptom free or with written veterinary clearance. Owner further agrees to maintain currency of vaccinations as required by Top Dog Kennel Club DBA Elizabeth Country Kennels policy.

8. All charges incurred by Owner shall be payable upon pickup of pet. Owner agrees that if a Third party, previously approved verbally or in writing by Owner and Top Dog Kennel Club DBA Elizabeth Country Kennels, picks up pet for Owner, said party will provide payment before pet is released from facility. Top Dog Kennel Club DBA Elizabeth Country Kennels shall have the right to hold pet until all charges are paid in full. In the event pet is unclaimed within ten days after the estimated date out, and/or charges are unpaid, Top Dog Kennel Club DBA Elizabeth Country Kennels shall dispose of the pet as it deems appropriate.

9. If pet becomes ill or injured, or if the state of the animal's health otherwise requires professional attention, Top Dog Kennel Club DBA Elizabeth Country Kennels, in its sole discretion, may engage the services of a veterinarian or give other requisite attention to the animal, and the expenses thereof shall be paid by the Owner. The owner further waives any right to dispute whether said expenses were reasonable, necessary and related to the care of the animal in question. Owner agrees to hold Top Dog Kennel Club DBA Elizabeth Country Kennels, its agents, principals and employees, harmless for any and all associated causes related to said injuries and illnesses, including death. Owner further understands that Top Dog Kennel Club DBA Elizabeth Country Kennels, shall not, at any time, provide veterinary services except for the distribution of pharmacological material(s) as instructed by Owner.

10. This Agreement contains the entire agreement between the parties. All terms and conditions of this Agreement shall be binding on the heirs, administrators, personal representatives and assigns of the Owner and Top Dog Kennel Club DBA Elizabeth Country Kennels.
